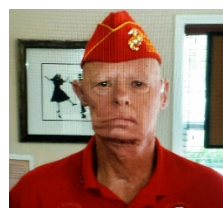

This allows us to focus on the Ruger Mini 14 Ranch Rifle Raffle Ticket Fundraiser. During our September meeting, *Ed* presented the fundraiser proposal. It was moved by *Thomas Mattocks* and seconded by *Ken Lepore*. The motion was voted unanimously. And guess what, as most of you already know some of us have already attacked the *Wiggs* and started selling raffle tickets. UNIFORM REGULATIONS

An excerpt from National Bylaws **UNIFORM CODE-MARINE CORPS LEAGUE ENCLOSURE THREE (3):**
"V MARINE CORPS LEAGUE COVER

A. The basic uniform of the Marine Corps League is the unique cover that identifies the members of the Marine Corps League. Because all other parts of the uniform that are designated in this enclosure are optional, the cover remains as the "only" consistent identifier for Marine Corps League members, which is why the cover is worn indoors at appropriate Marine Corps League functions. When Marine Corps League Members are wearing the appropriate cover, they are considered to be "in uniform". **NO OTHER TYPE OF COVER MAY BE WORN AT A MARINE CORPS LEAGUE FUNCTION OR MEETING.**

B. All members of the Marine Corps League are authorized to wear the **RED COVER**.

The one item that all members of the Marine Corps League must wear at meetings or official functions is the ***MCL Cover & Gold Eagle, Globe, & Anchor (EGA) Cap Ornament or the Associate Member's Cap Ornament***. That is the main/official requirement.

Cap Ornament-Associate (NON-MARINES, NON-FMF CORPSMEN & NON-FMF CHAPLAINS)

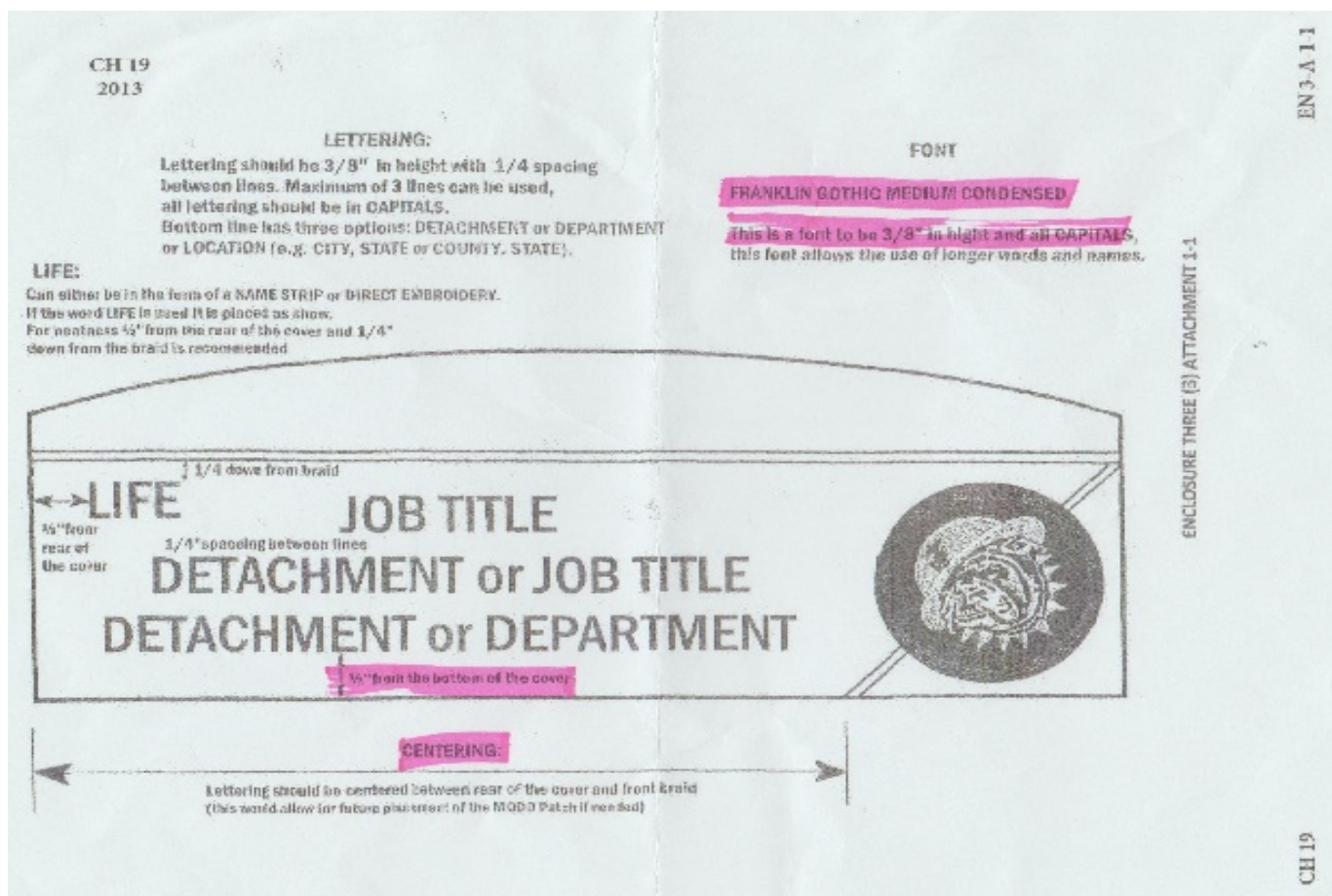

MARINE CORPS MEMORIES



The best and rewarding time I had in the Corps was when I was a Drill Instructor (69-72) at MCRD San Diego. Taking raw recruits who knew nothing about the Corps and in 8-12 weeks making them into a basically trained Marine. I am a Marine at heart with pride and still believe in honor, courage and commitment. (Nick Vultaggio, Master Sergeant)



As a Legal Service Specialist, I pride myself in ensuring that all deploying Marines had updated Wills, and Power-of-Attorneys. This was mandatory or the Marines could not be deployed! I became very close with these Marines. Before receiving orders to Okinawa, Japan, I was honored to be selected for the Honor Guard Detail. While some of those very Marines I helped were on deployment a disastrous accident happened upon the USS Tarawa, which I did not know about until I arrived in Japan. Over the years I think of those Marines I helped who lost their lives that day, and how being part of the Honor Guard Detail was an Honor. (Tonya G. Dallas, Corporal)



In 1943 I was a 17 year old in high school who wanted to be patriotic during World War II. There was a need for defense workers, and so I wanted to do my part in helping to support my country's war efforts. So every afternoon I went over to a company that was doing defense work. The supervisor I worked with was a Navy Veteran who convinced me that the Navy was a good place to enlist if I wanted to go into the service. A couple of months later I enlisted in the Navy and after going to Navy Boot Camp, I then went on to the Hospital Corps School where I was asked to join the US Marine Corps. In December of 1943 I was assigned to Company A, 1st Battalion, 26th Marine Regiment of the 5th Marine Division at Camp Pendleton, California.

Our Division was involved in the invasion of Iwo Jima, which was only 750 miles from the Japanese homeland. I landed on Feb 19, 1945 which was D Day at H hour plus 3 and performed the duties of FMF Navy Corpsman. As a young 19 year old, I grew up very quickly, seeing death and the carnage of war surrounding me everywhere. Aiding my fellow Marines who were wounded, and vigilantly staying awake without sleep for many nights straight while being on guard, I never knew if I would live to see the light of dawn..... It would be an experience I would carry with me for the rest of my life. I learned how critical it was to be my brother's keeper and knew that without a doubt each one of us had each other's back no matter what.

While attending to others I was shot and received the Purple Heart Medal, the Bronze Star with Combat V and the Silver Star Medal with Presidential Unit Citation for heroism.

To this day I continue to feel so much pride being a Marine. There were things that were instilled in me that I continue to hold dear and embody in my life, the values of honor, courage and commitment that took root while in the Marines. (Charles "Doc" Crum, FMF Corpsman)

MARINE CORPS MEMORIES



After enlisting in the US Navy, I began my service at the Banana River Naval Station in Cocoa Beach, FL. After WWII ended, I then enlisted in the Marine Corps and was sent to basic training at Montford Point, Camp Lejeune, NC. I spent 3 years as a drill instructor following boot camp before deploying to Korea for 2 years. Following my Korean deployment, I returned to the West Coast, and had duty assignments at Camp Pendleton, El Toro, and Twentynine Palms. In between stateside assignment, I had extended deployments to Japan and Vietnam. In addition to the Western Pacific assignments, I was temporarily deployed to Roosevelt Roads, PR, to train and then stage at sea for the potential amphibious support of the Cuban uprising at the Bay of Pigs. Lynn laughs to himself when he thinks about what a Marine Corps recruiter told him about joining. In 1952 Lynn was 5'3" and weighed only 114 pounds and the recruiter told him to "go home, boy"! Lynn was a jockey and he was required to keep his weight down. When Lynn returned, the recruiter made some "adjustments" in his height and weight...and as they say everything else is history! After basic training at Marine Corps Recruit Depot in San Diego, California, Lynn went on to having an amazing career in the Marine Corps. Lynn's leadership skills were recognized early on and ended up being the team leader for a radiation study. Later he would return to school and earned another certificate as a nuclear/biological/chemical warfare specialist. Lynn was discharged from the Marine Corps in 1959, to start a career in the movies. His interest was westerns and "they were making a lot of westerns", said Lynn. While working as an extra on hundredths of movies it was not enough money to support his family. Lynn eventually took a job as a truck driver, but when Teamsters went on strike and said that Lynn must walk a picket line, Lynn's response was "I don't walk a picket line for anybody". After Lynn's last delivery he went to the Marine Corps recruiting station to return to active duty. Lynn had been all over the world and done many things from troop leader to Counterintelligence. Lynn was wounded in a mortar round and shrapnel hit him in his right hip. He was evacuated to a field medical center. Lynn spent 30 years in the Marine Corps, and 24 of those years on active duty. 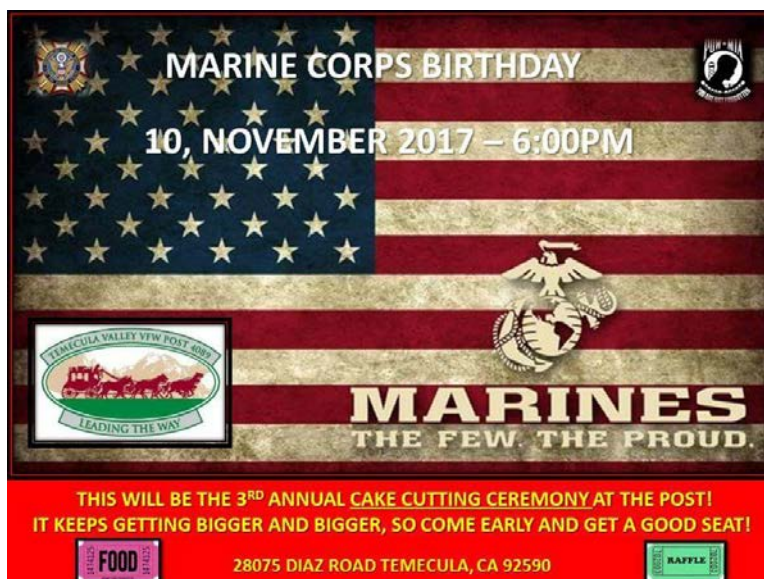
